Precept

This year the Council undertook its precept consultation online and received 10 responses from residents, although the Council notes this is a disappointing return it is the highest response we have received to date.

For the second year in a row the tax based which is used to calculate the council tax had reduced which meant that if we had frozen the precept at the same level as last year (£10,086) this would have resulted in Band D properties paying an extra £1 per year.

That the Council agreed a precept of £9,911 a 1% increase per Band D which equates to an increase of 36p for the year.

Look out for our Precept consultation later this year before we set the Precept for 2022-2021— it is usually published between November and January!

Planning

After a really quiet year last year in 2019-202 when we only received 6 planning applications, we have had an increase in planning applications in 2020-2021with 14 being considered, three of which reacted to various tree works in the village.

The Council has considered 2 barn conversions, one to create a dwelling with detached garage and a second to create a holiday let.

At the start of the Council year we received an application to create 10 glamping pods, erection of a café, farm shop, coffee roaster, pasteuriser and campsite amenity facilities, plus landscaping, access, parking and ancillary works. The Council resolved to support this application and subsequently the Chairman spoke in support of the application at the CW&C Planning Committee meeting, the application was approved 6 votes to 5.

The Council has considered two applications for The Stables off Duckington lane, the first to convert the existing stables into 2 dwellings and the second demolish the stables and erect 2 dwellings, the Parish Council objected to both applications on the grounds of building in the open countryside and the impact



this would have, both applications have been refused by CW&C, we wait to see if the second application goes to appeal.

Meetings & Attendance

Nobody could have foreseen the year we would have when we published our Annual Report for 2019-2020 this time last year, and we had just held our first couple of virtual meetings.

Throughout the year we have continued to hold all the Parish Council meetings virtually via Zoom. This has allowed those who were shielding to attend meetings along with members of the public both via the internet and by telephone.

In addition to our 6 scheduled meetings in May, July, September, November, January and March we have held 4 extraordinary meetings the majority of which have dealt with planning applications.

Six of the meetings were attended by all 8 Councillors, the other 4 meetings were attended by 7 Councillors. We have had an average attendance of 2 members of the public at each meeting, with 6 members of the public attending our extraordinary meeting in June.

CW&C Cllr Paul Roberts has also attended the majority of our meetings.

All our meetings include public participation and are open to the public and we would love to see more of you at our meetings in the future.

At the time of writing it is not clear if the ability for Parish Councils to meet virtually will continue as the legislation introduced in 2020 to allow this ends on the 7th May.



TILSTON WAR MEMORIAL HALL

As it has for all of us, the past year has been a challenging time for Tilston War Memorial Hall, with the hall being closed for over 10 months. Our Village Hall, normally so lively with a whole range of age groups, classes and interest clubs has been standing silent.

However, the TWMH Management Committee have been busy planning and have used this time to make some improvements to the hall, as much as funds will



allow. As well as decorating and new radiators, our biggest project was the refurbishment of the main hall floor. The hall floor is the original maple wood sprung floor from the Tilston Institute, opened in 1921, which was installed in the current village hall when construction began in 1976. It had been a project that we had planned prior to the pandemic, but at a cost of £4,000 it was one that needed careful consideration. The hall has not had any income from rentals during the pandemic, but the Committee felt it was the ideal time to undertake this major project while the hall was not in use, so the work went ahead and we are delighted with the results.

Our next major expense will be to make the roof water-tight. Unfortunately, the roof has sprung a few leaks over the last year and rainwater leaking through the ceiling means we have to have some strategically placed buckets around to catch the water!

For the Hall Committee, all of who are volunteers, the last year has meant we have had the opportunity to learn new skills, expanding our knowledge and involvement in health & safety, risk assessments and cleaning protocols. As a registered charity, TWMH operates on a limited budget, but the committee do their very best to ensure the hall is a welcoming environment and maintained to a good standard. It is difficult to predict what the coming year will mean for our Village Hall, with the amount of bookings and income unlikely to return to the level we had before the pandemic hit.

We would like to thank all those who give their time and support the hall in so many ways and to thank the hirers who have worked with us diligently during the pandemic to ensure the hall is as safe as possible for all users.

The Committee would also like to thank the Parish Council for their continued support of the hall and for the contribution towards our annual insurance premium which is very much appreciated.

There is usually a positive to be found in most situations and the last year has shown what a great and supportive community we have here in Tilston. We look forward to welcoming everyone back to our village hall when we are allowed to safely and fully re-open.

TPFA have maintained the field to a safe standard, adapting to government rules as required. Thanks go to the volunteer trustees for their continuing efforts. The present trustees are Gail Graham, Harry Downs, Penny Honeyborne, David Swift, Paul Montgomery, Mary Richardson, Simon Gerrard, Fiona Pountney and Harry Jarvis. Due to her commitment to running the Tilston Stores, Lynsey Jackson retired from committee and we thank her for her years of support. Richard Foden has recently joined the TPFA and we welcome his knowledge of equipment and cycling. Anyone in the community with comments to make on the running of the field, or who wish to get involved, can approach any of the Due to the pandemic our plans to refurbish the aforementioned.

Obviously due to the pandemic we have been unable to fundraise and had to cancel the sports week. We are very grateful to Tilston Parish Council for their support in contributing £1000 towards our annual insurance. Paul Roberts allocated £750 out of his CWAC member's budget enable to replace the spring and locking mechanism on the zip wire which had been condemned in our last ROSPA inspection. We have just been allocated £2000 out of the Fox and Hounds S106 money which will allow us to complete the groundwork below the zip wire. Being able to afford to do this is in part thanks to Matthew Honeyborne who is donating his time to complete the work and to Tony Dromgoole for providing the materials at

trade price.





Two other pieces of equipment will have to be removed and the tyre swings, wooden spider and swings refurbished. Matthew will also help trustees with this work. All this comes at a cost, and as the TPFA have no regular external funding, we look forward to being able to fundraise again to meet our annual expenses for field maintenance.

Alan and David Willett continue to mow the field and cut the hedges for us and allow us to use their adjacent field for event parking. Thank you to them and to Phil Evans, who gives his time freely to keep our mole problem under control. S P Mowers have taken over the contract for keeping the equipment areas of the field mown and tidy and are doing an excellent job, thank you.

St. Mary's Church, Parish Council Report, 2020-2021

2020 should have been an exciting year for St. Mary's Church, following the arrival of a new Rector in January and an induction service, led by Bishop Keith, the Bishop of Birkenhead, in early February. Members of local community groups were present, to welcome myself as the new Rector, and my wife, Norma, as the new Associate Minister.

Sadly, we had only been in post six weeks when the first covid 19 lockdown stated in late March. What followed was a prolonged period when church services were held entirely online via Zoom. Although interaction, and a degree of fellowship, is possible via Zoom, this is a poor substitute for face-to-face contact. In fact, much of the pastoral work that we were able to engage with in 2020 was made via the telephone. Although it was good to chat, as newcomers, not being able to put a face to a voice is rather frustrating!

In the late Summer, early Autumn, as lockdown eased, it was, however, possible to hold a series of small garden parties. A 'What's App' support group was also established to offer practical support to the most vulnerable, who had to shield during the pandemic crisis. On the plus side, this resulted in a sense of community solidarity and awareness of the needs of others.

It was also possible to hold the annual Rushbearing and Harvest services outside the church in the churchyard. The

prohibition of singing, and the imposition of masks and social distancing during worship has, however, given worship an unfamiliar feel. Many worshippers, especially those who understandably feel vulnerable, have continued with Zoom worship.

The start of 2021, and the second major lockdown, saw a return to Zoom services and no church worship until late March. It is hoped that, as vaccinations increase, and covid 19 infection rates drop, the church will be able to return to 'normal' worship, with other church activities being reestablishing by the summer.

We are looking forward to welcoming people to the Rectory or visiting them. Please don't hesitate if you would like to meet us face-to-face.

Your CW&C Ward Councillor Paul Roberts—Report

Inevitably the past year has been overshadowed everywhere by the Covid crisis. I don't have any data for individual villages, but Farndon Ward residents have suffered fewer infections than the average for Cheshire West, but of course there are still a lot of people who have been badly affected by Covid locally.



Whilst there are always things which could have been done differently or better, my impression is that the various agencies in Cheshire West have handled the crisis reasonably well. Certainly the vaccine roll out seems to have gone particularly well locally.

Flooding is a different story: CWaC have a poor record of maintaining highway drainage. Where blocked drains are reported, they are usually eventually jetted, but often without checking for the underlying cause of the blockage, which means that problems keep recurring. If you notice that a drain is blocked, please report it via CWaC's web site (Highway faults). If it keeps being blocked, let me know.

Several planning issues have been important in Tilston over the past year – I was very pleased to work with the Parish Council and others in support of the Old Hall Farm "Glamping" application, which was opposed by the Planners on what I felt were very narrow interpretations of the policies. The online meeting was quite tense, and it was a great relief when the Committee decided by a single vote to allow the application, which I'm sure will benefit local businesses.

There are many organisations in Tilston doing great work for the community, but I would particularly like to congratulate Tilston Playing Fields Association for their work in taking the facilities from strength to strength – the Pump track in particular is the subject of envy from many other villages. I was pleased to be able to support the Association in a small way through my Member's Budget.

The Parish Council of course continues to operate very effectively – I'm always pleased to work with them.
